Notes to Exhibitors

- In accordance with Chapter 1, Section 2, of the *Obedience Regulations*, entry preference is given to English Springer Spaniels, and separate awards will be given to English Springer Spaniels.
- CESSCGA reserves the right to refuse any entry.
- “Effective for all events held on and after January 1, 2008, The American Kennel Club will collect a \$3.00 event service fee for the first entry of a dog and a \$3.00 service fee for each additional entry of the same dog in the regular and non-regular recordable single entry classes, in all AKC licensed and member club events. (There is no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes, or special attractions.) The current 50 cent recording will continue to be collected. The event-giving club shall assume the responsibility of collecting all Event Service Fees for the American Kennel Club.”—Chapter 11, Section 2 of AKC’s *Rules Applying to Dog Shows*.
- Indicate ‘UDX’ if you are entering both Open B & Utility B and you do not want to enter at all if one class or the other is already closed due to entry limitations (*Obedience Regulations: Chapter 1 Section 27*).
- Move-ups are permitted at these trials. In accordance with Chapter I, Section 16a: “The request for a move-up must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial.”
- No refund will be given for duplicate entries.
- Bitches in season: In accordance with Chapter 1, Section 14, of the *Obedience Regulations*, CESSCGA will issue refunds for bitches that come into season and for which the event secretary is notified no later than 30 minutes before the start of the first class of the trial. CESSCGA will retain a processing fee of \$7 per class. A veterinarian’s certification that the bitch is in season is required.
- Owners are responsible for accuracy of information on entry forms. After the closing date, no entry fees will be returned in the event of errors or cancellation of entries. Entries will not be accepted without fees or signature.
- Entries not on an official AKC entry form that includes the agreement will not be accepted.
- Returned checks do not constitute a valid entry fee. The Event Secretary will add a \$50 collection fee to the amount of each returned check.
- No entry fee will be refunded for a dog that is absent or is excused or disqualified by the judge or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed because of riots, civil disturbances, fire, extreme and/or dangerous weather, act of God, public emergency, act of public enemy, or any other cause beyond the control of the club or the Event Secretary.
- Entries submitted by phone will not be accepted.
- Changes, additions, or corrections to entry forms must be submitted in writing and received by the Event Secretary before 9 PM on Wednesday, July 22, 2015.
- All checks and money orders must be in U.S. funds.

- Catalogs are available by preorder only. Cost is \$3.00. One catalog covers the entire weekend
- Trial hours: 7 AM.–7 PM each day.
- ADOG's building is a 5,800 square-foot facility, air conditioned and fully matted. Crating space is limited, so we request that you bring stackable crates if you have multiple dogs. To protect the mats, please place pads or towels under your crates.
- This is a one-ring trial.
- The "show grounds" for these trials consists of the show building and the parking lot.
- The building will be available to exhibitors at 7 AM on Friday, August 7, 2015. The building will not be available for set-up on Thursday.
- Crates and chairs may remain in the building each night. Dogs must be removed from the building within 30 minutes after judging ends each day.
- The parking area has limited space behind the building for RVs; no hook-ups are available.
- On Friday, August 7, do not park in front of the other businesses; sufficient parking is available behind ADOG's building.
- Smoking is not permitted in the building.
- Bring your own shade and chairs.
- All dogs must be on lead both inside and outside the building except when in the ring.
- Judges will not wait for dogs holding up a ring.
- At both the show site and the motels, please pick up after yourselves and your dogs.
- Dumpsters in and around the parking lot cannot be used for any trash.
- Any complaints from motels regarding exhibitors may result in a Trial Committee hearing.
- A dog that bites a person on the Show Grounds may be reported by the Show Committee to DeKalb County Animal Control.
