Miscellaneous

The A.K.C. and CESSCGA require *blaze orange clothing* be worn when in the Hunting Test field. Severe training, correcting, or disciplining of dogs will not be permitted on the Hunting Test grounds. Refund policy: Entry fees (minus AKC fees if cancelled after closing) will only be refunded for: (1) a bitch in season—with a letter from a veterinarian; (2) a dog that is injured, ill, or dies—with a letter from a veterinarian; or (3) an entry cancelled prior to closing who does not run.

Directions to Headquarters and the Hunt Test Site:

From Atlanta to Headquarters:

Take I-85 N toward Greenville and drive about 80+ miles
Take exit #160/Royston/Elberton - go 0.3 miles
Turn Right on GA-51 - go 10.0 miles
Bear Right on GA-145 - go 1.2 miles
Turn Left on US-29 - go 3.0 miles
Turn Right on GA-17-BR - go 1.2 miles
Continue on GA-17 - go 6.2 miles
Turn Right on South Broad Street (GA-172) - go 0.3 miles
Turn Left on Rehoboth Road and then bear Right
Turn Left on Martin Road - go 0.4 miles
Arrive at 2840 Martin Road, on the Left

From Headquarters to the Hunt Test Field/Water:

Start at 2840 Martin Road and take a Left out of the driveway - go 0.1 miles
Bear Right on Harris Road - go 0.6 miles
Turn Right on Stanley Maxwell Road - go 0.5 miles
Arrive at 2785 Stanley Maxwell Road, on the Left
